STAFF'S RECOMMENDED BOARD MOTION

Approve the merger of the Belmont and Belmont II Community Development Districts (CDD) in accordance with the attached ordinance. No direct financial impact to the County will occur as a result of this petition.

FINANCIAL IMPACT STATEMENT

No direct financial impact to the County will occur as a result of this petition.

BACKGROUND

On February 10, 2006, the Board of County Commissioners (Board) adopted Ordinance 06-04, as subsequently amended by Ordinance 18-26, establishing the Belmont CDD. On October 16, 2018, the Board adopted Ordinance 18-27 establishing the Belmont II CDD. On February 24, 2025, the two CDD's petitioned Hillsborough County to merge the two districts. The applicant's representatives is Lindsay Whelan, Kutak Rock LLP.

The Belmont CDD is \pm 509.229 acres and the Belmont II CDD is \pm 356.906 acres. The merged CDD Development District will be \pm 866.135 acres and shall be known as the Belmont Community Development District. It is generally located on south of Big Bend, east of I-75, west of US Hwy 301 and north of the Bull Frog Creek Preserve. Please see Attachment A for the CDD's location. The Board of Supervisors of the Belmont CDD and Belmont II adopted Resolution 2025-03 which approved the form of the Merger Agreement (Attachment B), which pursuant to Section 190.046(3), Florida Statutes constitutes consent of all landowners within the districts.

BACKGROUND - Continued:

The Belmont and Belmont II CDD's (Merger area) are located within Planned Development (PD) zoning district PD 04-0558. The PD is approved for 2,260 residential units, 112,000 square feet of commercial, a 300-child day care and a community school/area. The PD permits single family detached units and single-family attached (townhomes). It is anticipated the Merger area will contain 2,054 units consisting of 413 single-family attached (townhomes) units and 1641 single-family detached lots (40'- 60' lot widths).

The statutory purpose of a CDD is to plan, finance, construct, and/or acquire, operate, and maintain community-wide infrastructure in large, planned community developments. A CDD is not a substitute for the local general purpose government unit, i.e. the City or County in which the CDD lies. A CDD lacks the powers of permitting, zoning, police, and many other authorities possessed by the general purpose governments.

A CDD is an independent special-purpose, local government taxing district authorized by Chapter 190, F.S. (Uniform Community Development Act of 1980, Section 190.002(1)a F.S.). The Uniform Community Development Act requires a public hearing on the petitioned request.

The petition includes the following items required by Section 190.046(3) F.S. which addresses the merging of CDD's:

- A metes and bounds description of the external boundaries of the district
- A statement of estimated regulatory costs in accordance with the requirements of s.120.541, F.S.
- The proposed timetable for construction of District services
- A map showing the current major trunk water mains and sewer interceptors and outfalls
- The estimated costs of constructing the proposed services for the Merger area and,
- A designation of the future general distribution, location and extent of public and private uses of land proposed for the area within the merged District boundaries.

The above information was received by Hillsborough County and was made part of the review for the proposed CDD merger.

Chapter 190, F.S., establishes six criteria that a petition must meet to merit approval for the merger of the CDD's. The six requirements include:

- 1) That all statements contained within the petition have been found to be true and correct.
- 2) That the merger of the Districts is not inconsistent with any applicable element or portion of the State Comprehensive Plan or the effective local government comprehensive plan.
- 3) That the land area within the merged district is of sufficient size, sufficiently compact, and sufficiently contiguous to be developable as one functional, interrelated community.
- 4) That the creation of the merged District is the best alternative available for delivering the community development services and facilities to the area that will be served by the District.
- 5) That the proposed services and facilities to be provided by the merged District are not incompatible with the capacity and uses of existing local and regional community development district services and facilities.
- 6) That the area proposed to be included in the merged District is amenable to separate special district government.


Review Performed by County


No objections to the merger of the CDDs were raised by reviewing agencies.

Staff from the Management and Budget conducted a financial review of both districts involved to determine the financial impact of the merger on stakeholders. In particular, the review focused on the financial impact of the merger on assessment payers and bondholders. To determine the appropriateness of combining and merging the Belmont CDD and Belmont II CDD, the financial position of each district was evaluated. Staff from Management and Budget examined whether: as of the most recent financial audit date, each district had a positive cash balance; was current on its debt payments; realized revenues in excess of expenses; and

experienced an immaterial level of delinquent assessment payments. For fiscal 2023 (the most recent year for which audited financial statements are available), both Belmont CDD and Belmont II CDD received unmodified (clean) audit opinions, and satisfied each of the previously specified criteria. Additionally, staff sought to confirm that no assessment payers would be adversely financially impacted as a result of the merger, meaning that neither the annual assessment for debt repayment nor the annual assessment for operating and maintenance expenses would increase. The attorney leading the merger effort has confirmed that assessments will not increase as a result of the merger. The County's financial review of Belmont CDD and Belmont II CDD indicates that both districts are in sufficient financial health to enter into the desired merger arrangement, and that no stakeholders will be negatively financially impacted because of the merger.
Based on the information contained in this petition and reviews of county departments, staff finds that the petition meets the criteria contained in Chapter 190, F.S., for the merger of the Belmont and Belmont II CDD's which shall be known now as Belmont Community Development District.

MERGER AGREEMENT BY AND BETWEEN BELMONT COMMUNITY DEVELOPMENT DISTRICT AND BELMONT II COMMUNITY DEVELOPMENT DISTRICT

This Merger Agreement (the "Agreement") is made and entered into by and between the following:

Belmont Community Development District, a local unit of special-purpose government established pursuant to Chapter 190, *Florida Statutes*, and located in Hillsborough County, Florida ("Belmont CDD"); and

Belmont II Community Development District, a local unit of special-purpose government established pursuant to Chapter 190, *Florida Statutes*, and located in Hillsborough County, Florida ("Belmont II CDD," and together with Belmont CDD, the "Districts"); and

RECITALS

WHEREAS, Belmont CDD was established by Ordinance 06-04 by the Board of County Commissioners of Hillsborough County, Florida (the "BOCC") effective as of February 10, 2006 for the purposes of planning, financing, constructing, operating and/or maintaining public infrastructure improvements over approximately 885.816 acres serving the Belmont residential community; and

WHEREAS, the boundary of Belmont CDD was amended to add certain lands and to remove approximately 376.678 acres pursuant to Ordinance 18-26 adopted by the BOCC, effective as of October 16, 2018, for a current district acreage of 509.229 acres; and

WHEREAS, Belmont II CDD was established by Ordinance 18-27 adopted by the BOCC effective as of October 16, 2018 for the purposes of planning, financing, constructing, operating and/or maintaining public infrastructure improvements over approximately 356.906 acres serving the Belmont residential community that was removed from the boundary of Belmont CDD pursuant to Ordinance 18-26; and

WHEREAS, Section 190.046(3), Florida Statutes, authorizes the merger of community development districts and provides that, prior to filing a petition requesting such merger, the districts desiring to merge enter into a merger agreement which provides for the proper allocation of the indebtedness assumed by the merged district and the manner in which such debt shall be retired; and

WHEREAS, Section 190.046(3), Florida Statutes, provides that the approval of the merger agreement and the petition by the board of supervisors of each district shall constitute the consent of the landowners within such district with respect to the merger; and

WHEREAS, due to the interrelated nature of the Districts within the Belmont community, a merger of the Districts (hereinafter, the "Merger") is in the best interests of the residents and landowners of both Districts because, among other reasons, the Merger would promote greater efficiency in the Districts' operations, eliminate redundant costs and other expenses, and reduce future operations and maintenance assessments in the aggregate; and

WHEREAS, the Board of Supervisors (the "Board(s)") of both Belmont CDD and Belmont II CDD have duly adopted Resolutions 2025-03 and 2025-03, respectively, evidencing each District's intent to effectuate the Merger between the Districts, directing the Districts' staff to take all actions necessary in effectuating same, and approving the form of an agreement between the Districts related to the merger and of the petition requesting the Merger (collectively, the "Merger Approval Resolutions"); and

WHEREAS, in accordance with Section 190.046(3), Florida Statutes, Belmont CDD and Belmont II CDD accordingly desire to set forth their mutual understanding, rights and obligations with respect to the Merger.

NOW, THEREFORE, based upon good and valuable consideration and the mutual covenants of the parties, the receipt of which and sufficiency of which are hereby acknowledged, the parties agree as follows:

- Recitals and Authority. The foregoing recitals are true and correct and by this
 reference are incorporated as a material part of this Agreement. This Agreement is entered into
 pursuant to the provisions of Florida law, including, but not limited to, Chapter 190, Florida
 Statutes.
- 2. The Merger. Pursuant to the Merger Approval Resolutions, the Districts shall cause to be filed with the BOCC a petition (hereinafter, the "Merger Petition") requesting that the BOCC adopt an ordinance (the "District Merger Ordinance") that would effectuate the Merger of Belmont II CDD into and with Belmont CDD. The Merger shall become effective sixty (60) days following the BOCC's adoption of the District Merger Ordinance (the "Merger Effective Date"). The sixty (60) day period preceding the Merger Effective Date shall be referred to as the "Interim Merger Period." On the Merger Effective Date, the Districts shall be merged together and the surviving entity shall be known as "Belmont Community Development District" (the "Merged District"). Belmont II CDD shall thereafter cease to exist. It is the intent of the Districts that the transfer, assignment, vesting, and assumption of all rights, property, assets, assessments, contracts, agreements, insurance, debts, and liabilities from the Districts into the Merged District shall automatically occur on the Merger Effective Date, by virtue of the Merger pursuant to Section 190.046(3), Florida Statutes.

- 3. <u>Delegation of Authority; Cooperation</u>. This Agreement supplements, as necessary, the authorization, direction and delegation of authority to the Districts' Chairpersons, Vice Chairpersons, and District officers and/or staff (collectively, "District Staff") as provided in the Merger Approval Resolutions to further authorize and delegate to District Staff the authority to effectuate the transfer of powers, duties, liabilities, claims and assets, etc. as may be necessary to effectuate the Merger. The Districts agree to continue to cooperate and take all actions reasonably necessary and in a timely manner to permit a prompt response in all proceedings relating to the Merger.
- 4. Funding. The Districts recognize that in order to seek a Merger pursuant to Chapter 190, Florida Statutes, District Staff, including but not limited to legal, engineering, financial and managerial staff, among others, must provide certain services necessary to the effectuate the same. Accordingly, the Districts agree to provide the funding necessary for the effectuation of the Merger, which shall be shared equally.
- Legal Opinions. The Districts shall cause to be provided, or otherwise obtain, any legal opinions necessary to effectuate the Merger, if necessary.
- 6. <u>District Name and Boundaries</u>. As set forth in Section 2 herein, upon the Merger Effective Date, the name of the Merged District shall be the "Belmont Community Development District." As of the Merger Effective Date, the boundaries of Merged District shall be as set forth in Exhibit A, attached hereto and incorporated herein by reference.

Board Members.

- A. As of the Merger Effective Date, the Board of the Belmont II CDD shall cease to exist and the Belmont II Board members shall cease to hold office.
- B. To facilitate the Merger, Edward Westergaard and Kevin Stowe, who currently occupy Seats 1 and 4 on the Belmont CDD Board, have placed their irrevocable resignations in escrow with the Belmont CDD District Manager to be effective upon the Merger Effective Date (the "Vacated Board Seats"). For the avoidance of doubt, as of the Merger Effective Date, the Board of Supervisors of the Merged District (the "Merged District Board") shall be comprised of the following individuals:

Seat 1 - Vacant

Seat 2 - Carl Brothers

Seat 3 - Shannon Carey

Seat 4 - Vacant

Seat 5 - Kristen Brooks

C. Within thirty (30) days after the Merger Effective Date, the Merged District Board agrees to appoint now-current Belmont II CDD Board members La-El Carter and Jennifer Holliday to fulfill the terms of the Vacated Board Seats (the "Merged District Board Appointees"). Upon the appointment of the Merged District Board

Appointees, the Merged District Board shall thereafter be comprised of the following individuals:

Seat 1 - La-El Carter

Seat 2 - Carl Brothers

Seat 3 - Shannon Carey

Seat 4 - Jennifer Holliday

Seat 5 - Kristen Brooks

- D. In the event that the Merged District Board Appointees are no longer Belmont II CDD Board members as of the date of Merger Effective Date or are otherwise unable or unwilling to accept such appointment, the Merged District Board shall appoint one or two, as the case may be, other then-existing Belmont II CDD Board members to the Vacated Board Seats.
- E. Seats 1 and 2 of the Merged District Board shall hold terms expiring in November 2028 (and thereafter in November 2032), and Seats 3, 4 and 5 of the Merged District Board shall hold terms expiring in November 2026 (and thereafter in November 2030). Elections of the Merged District Board shall be held in accordance with the requirements of Section 190.006, Florida Statutes.
- 8. Property & Assets. Effective as of the Merger Effective Date, Belmont II CDD passes all title, rights, ownership of property, moneys, uncollected taxes and/or assessments, dues, receivables, claims, and judgments held and owned by Belmont II CDD (the "Belmont II CDD Assets") to Belmont CDD. By execution of this Agreement, and as of the Merger Effective Date, Belmont CDD accepts and is hereby vested with the authority necessary to effect such transfer from or on behalf of Belmont II CDD, and receive such title, rights, ownership of property, moneys, uncollected taxes and/or assessments, dues, receivables, claims and judgments.

Assessments.

- A. Effective as of the Merger Effective Date, all non-ad valorem or special assessments levied by Belmont II CDD against property in Belmont II CDD, whether for operations and maintenance or for debt service (the "Belmont II CDD Assessments"), shall be payable when due to Belmont CDD. As of the Merger Effective Date, the Belmont II CDD delegates, and the Belmont CDD accepts, the authority to collect upon and enforce any such assessment liens securing the Belmont II CDD Assessments, whether under the Uniform Method of Collection or any other method under Florida law.
- B. Following the Merger Effective Date, there shall be no change in the assessment liens on the specific lands securing the outstanding i) \$5,865,000 Belmont II Community Development District (Hillsborough County, Florida), Special Assessment Revenue Bonds, Series 2019 and ii) Belmont II Community Development District (Hillsborough County, Florida) Special Assessment Revenue Bonds, Series 2020 (collectively, the "Belmont II CDD Bonds") issued by the

Belmont II CDD by virtue of the Merger contemplated herein, except that the liens securing the Belmont II CDD Bonds shall thereafter be in favor of and imposed and collected by, the Belmont CDD. For the avoidance of doubt, there shall be no change or impact on the assessment liens on the specific lands securing the outstanding i) \$6,710,000 Belmont Community Development District (Hillsborough County, Florida), Capital Improvement Revenue Bonds, Series 2013A (Phase I Project), ii) \$9,840,000 Belmont Community Development District (Hillsborough County, Florida), Capital Improvement Revenue Bonds, Series 2016A and iii) \$5,310,000 Belmont Community Development District (Hillsborough County, Florida), Capital Improvement Revenue Bonds, Series 2016B issued by the Belmont CDD by virtue of the Merger contemplated herein.

- 10. Contracts. Effective as of the Merger Effective Date, Belmont CDD shall be responsible for, and bound by, all contracts to which Belmont II CDD is a party (the "Belmont II CDD Contracts"). Belmont CDD shall assume the liabilities arising from the Belmont II CDD Contracts and be entitled to the benefits of the same by operation of law. In addition, this Agreement shall effect the assignment, if needed, of the Belmont II CDD Contracts to Belmont CDD as of the Merger Effective Date with no further action required on behalf of the Districts unless consent by assignment is required by a third party. If such consent is required by a third party, Belmont CDD shall obtain such consent to assignment or terminate the contract in accordance with its terms. By execution of this Agreement, Belmont II CDD delegates, and Belmont CDD accepts, the authority to enforce and/or effect the disposition of all Belmont II CDD Contracts, including but not limited to the assignment, amendment, and/or termination of the same.
- 11. Interlocal Agreements Between the Districts. As of the Merger Effective Date, that certain Interlocal and Cost Share Agreement Regarding Shared Improvement Operation and Maintenance Services and Providing for the Joint Use of Amenity Facilities dated November 21, 2018, and recorded in the Official Records of Hillsborough County, Florida as Instrument No. 2018482470, as amended by that certain First Amendment dated July 21, 2020 and recorded in the Official Records of Hillsborough County, Florida as Instrument No. 2020310518 and that certain Second Amendment dated December 18, 2024 and recorded in the Official Records of Hillsborough County, Florida as Instrument No. 2025031566, each by and between the Districts (collectively, the "District Interlocal Agreement") shall be terminated and the Belmont CDD shall promptly record a notice of termination in the Official Records of Hillsborough County; provided, however, that Belmont CDD shall be entitled to levy special assessments against lands formerly within the Belmont II CDD for any payments due and outstanding to the Belmont CDD pursuant to the District Interlocal Agreement.
- 12. <u>Debts & Liabilities</u>. Effective as of the Merger Effective Date, Belmont CDD shall be responsible for and have the obligation of all debts and liabilities of Belmont II CDD (the "Belmont II CDD Debts & Liabilities") by operation of law. The Districts agree that, pursuant to Section 190.046, Florida Statutes, the Merger shall not impair the rights of creditors and liens upon Belmont II CDD property, if any. Moreover, Belmont CDD may be substituted for Belmont II CDD in any claim existing, or action or proceeding pending by or against Belmont II CDD. To the extent necessary, the Belmont II CDD delegates, and Belmont CDD accepts, the authority to

satisfy, fulfill, and pay all Belmont II CDD Debts & Liabilities and defend against any claim or action proceeding by or against Belmont II CDD effective as of the Merger Effective Date.

- 13. <u>Insurance</u>. Belmont II CDD shall terminate its insurance coverage effective thirty (30) days from the Merger Effective Date. Belmont CDD shall ensure that payment of the premium for that coverage is made so as to prevent any lapse in coverage, and shall be entitled to receive any refund of any overpayment for such insurance due to the cancellation.
- 14. Audits. Effective as of the Merger Effective Date, Belmont II CDD hereby authorizes the Belmont CDD to conduct, approve, and submit to appropriate authorities a final audit of Belmont II CDD's financial records pursuant to Section 190.007(2), Florida Statutes, and the submittal of any additional financial reports or statements required by law. By execution of this Agreement, Belmont CDD agrees to conduct, approve, and submit to appropriate authorities a final audit of Belmont II CDD's records pursuant to Section 190.007(2), Florida Statutes, and to submit all required additional financial reports or statements required by law. The Districts agree that the preparation of the above-referenced audit shall not commence until after the Merger Effective Date.
- authorizes Belmont CDD to assume control of all bank accounts held in the name of Belmont II CDD (the "Belmont II CDD Bank Accounts"), and to take any actions necessary to utilize such funds to pay obligations of Belmont II CDD which may become due after the Merger Effective Date or to transfer any funds remaining in such accounts into Belmont CDD accounts. Such actions may include, but are not limited to, the expenditure of funds from the Belmont II CDD Bank Accounts for payment of services rendered to Belmont II CDD prior to the Merger Effective Date, the transfer of such funds from Belmont II CDD to Belmont CDD, and the closing of such Belmont II CDD Bank Accounts which shall occur within forty-five (45) days of the Merger Effective Date. By execution of this Agreement, and as of the Merger Effective Date, the Belmont CDD accepts such control over the Belmont II CDD Bank Accounts.
- 16. <u>Budgets</u>. By execution of this Agreement, and effective as of the Merger Effective Date, the Belmont II CDD delegates to Belmont CDD the authority to consolidate the Belmont II CDD budget with the Belmont CDD budget for the then-current fiscal year, and Belmont CDD agrees to take any and all such actions with respect to the consolidation of the Districts' budgets. As the Districts acknowledge that the necessary amendments to Belmont CDD's budget to reflect the Merger must occur after the closing of the financial accounts and records of Belmont II CDD, Belmont CDD agrees to amend the Belmont CDD budget to reflect the Merger, including amendments to both revenues and expenses, within sixty (60) days of the Merger Effective Date.
- 17. Rules and Policies. At the time of this Agreement, Belmont CDD has adopted those certain Amended and Restated Rules of Procedure and those certain Policies, Rules, and Rates for All Amenity Facilities (collectively, the "Belmont CDD Rules and Policies"). As of the Merger Effective Date, the Belmont CDD Rules and Policies shall apply to the lands within the Merged District.

- Powers. As of the Merger Effective Date, Belmont CDD shall continue to have all
 of its existing general and special powers as granted by Ordinance 06-4.
- 19. <u>Default and Protection Against Third Party Interference</u>. A default by either party under this Agreement shall entitle the other to all remedies available at law or in equity, which may include, but not be limited to, the right of damages and/or specific performance. Each party shall be solely responsible for enforcing its rights under this Agreement against any interfering third party. Nothing contained in this Agreement shall limit or impair a party's right to protect its rights from interference by a third party to this Agreement.
- 20. Amendments. Amendments to and waivers of the provisions contained in this Agreement may be made only by an instrument in writing approved by the Boards of both Districts.
- 21. <u>Authorization</u>. The execution of this Agreement has been duly authorized by the Boards of both Belmont CDD and Belmont II CDD, both parties have complied with all the requirements of law, and both parties have full power and authority to comply with the terms and provisions of this instrument.
- 22. Arm's Length Transaction. This Agreement has been negotiated fully between the parties as an arm's length transaction. Both parties participated fully in the preparation of this Agreement and received the advice of counsel of their choosing. In the case of a dispute concerning the interpretation of any provision of this Agreement, both parties are deemed to have drafted, chosen, and selected the language, and the doubtful language will not be interpreted or construed against either party.
- 23. Third Party Beneficiaries. This Agreement is solely for the benefit of the parties and no right or cause of action shall accrue upon or by reason, to or for the benefit of any third party not a formal party to this Agreement. Nothing in this Agreement expressed or implied is intended or shall be construed to confer upon any person or entity other than the parties any right, remedy, or claim under or by reason of this Agreement or any of the provisions or conditions of this Agreement.
- 24. <u>Assignment</u>. Neither party may assign any part of this Agreement without the prior written approval of the other. Any purported assignment without such written consent shall be void.
- 25. <u>Controlling Law: Venue</u>. This Agreement and the provisions contained in this Agreement shall be construed, interpreted, and controlled according to the laws of the State of Florida. Venue shall be in Hillsborough County, Florida.
- 26. <u>Severability</u>. The invalidity or unenforceability of any one or more provisions of this Agreement shall not affect the validity or enforceability of the remaining portions of this Agreement, or any part of this Agreement not held to be invalid or unenforceable.

- 27. <u>Sovereign Immunity</u>. Nothing in this Agreement shall constitute or be construed as a waiver of either party's limitations on liability, as set forth in Section 768.28, *Florida Statutes*, or other applicable statute or law.
- 28. Enforcement of Agreement. In the event that either party is required to enforce this Agreement by court proceedings or otherwise, the parties agree that the substantially prevailing party shall be entitled to recover from the other party all fees and costs incurred, including reasonable attorneys' fees, paralegal fees, and expert witness fees and costs for trial, alternative dispute resolution, or appellate proceedings.
- 29. <u>Headings for Convenience Only</u>. The descriptive headings in this Agreement are for convenience only and shall not control nor affect the meaning or construction of any of the provisions of this Agreement.
- 30. <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, each of which when executed and delivered shall be an original. However, all such counterparts together shall constitute one and the same instrument. Signature and acknowledgment pages, if any, may be detached from the counterparts and attached to a single copy of this document to physically form one document.
- 31. Effective Date: Merger Effective Date and Termination. This Agreement shall be effective upon the recordation of a fully-executed copy of the Agreement in the Official Records of Hillsborough County, Florida. The Agreement shall continue to be effective until the earlier of either: (a) the date following the Merger Effective Date upon which all obligations and requirements set forth under this Agreement have been satisfied; or (b) termination of this Agreement upon sixty (60) days written notice by the terminating party. The terminating party shall record a Notice of Termination of this Agreement immediately after the effective date of termination.

AN ORDINANCE MERGING BELMONT COMMUNITY DEVELOPMENT DISTRICT AND BELMONT II COMMUNITY DEVELOPMENT DISTRICT AND ESTABLISHING THE BELMONT COMMUNITY DEVELOPMENT DISTRICT PURSUANT TO CHAPTER 190, FLORIDA STATUTES; SPECIFYING GENERAL AND SPECIAL POWERS OF THE DISTRICT; DESCRIBING THE BOUNDARIES OF THE DISTRICT; NAMING THE MEMBERS OF THE BOARD OF SUPERVISORS; PROVIDING FOR THE ADMINISTRATION AND FINANCING OF THE DISTRICT; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Belmont Community Development District and Belmont II Community Development District (the "Petitioners") have filed a Petition with Hillsborough County requesting that the Board of County Commissioners of Hillsborough County (the "County") adopt an ordinance merging the Petitioners into one district and establishing the Belmont Community Development District pursuant to Chapter 190, *Florida Statutes* (the "Merged District"), and designating the real property described in **Exhibit A**, attached hereto, as the area of land for which the Merged District is authorized to manage and finance basic service delivery; and

WHEREAS, the Petitioners have taken all actions required by Chapter 190, Florida Statutes as conditions precent to a merger of their Districts into one resultant Merged District; and

WHEREAS, the County has held a public hearing on the Petition in accordance with the procedural requirements of Section 190.005(1)(d) and 2(b), and 190.046(3) Florida Statutes; and

WHEREAS, upon the consideration of the record established at that hearing and the factors set out in Section 190.005(1)(e), *Florida Statutes*, the County determined that the

Merged District will constitute a timely, efficient, effective, responsive and economic way to deliver community development services in the area described by the Petition.

SECTION 1. FINDINGS OF FACT. The County hereby finds and states that:

- The "WHEREAS" clauses stated above are adopted as finding of fact in support of this Ordinance;
- 2. All statements contained in the petition are true and correct;
- The establishment of the Merged District is not inconsistent with any applicable element or portion of the State Comprehensive Plan or the County's Comprehensive Plan;
- The area of land within the proposed Merged District is of sufficient size, is sufficiently compact and is sufficiently contiguous to be developable as one functional interrelated community;
- The creation of the Merged District is the best alternative available for delivering community development services and facilities to the area that will be served by the District;
- 6. The proposed community development services and facilities to be provided by the Merged District will not be incompatible with the capacity and uses of existing local and regional community development services and facilities; and

7. The area what will be served by the Merged District is amenable to separate, special district government.

SECTION 2. <u>CONCLUSIONS OF LAW</u>.

- 1. This proceeding is governed by Chapter 190, *Florida Statutes*;
- 2. The County has jurisdiction pursuant to Section 190.005(2) and 190.046(3), Florida Statutes; and
- The granting of the Petition complies with the requirements of Chapter 190,
 Florida Statutes.

SECTION 3. NAMING OF THE DISTRICT. There is hereby created a community development district situated entirely within unincorporated Hillsborough County, Florida, which shall be known as the "Belmont Community Development District."

SECTION 4. <u>CREATION AND BOUNDARIES</u>. The external boundaries of the Merged District are described in **Exhibit A** attached hereto, the overall parcel containing 866.135 acres, more or less.

SECTION 5. <u>INITIAL BOARD</u>. The following five persons are designated as the initial members of the Board of Supervisors of the Merged District consistent with the requirements of Chapter 190.046, *Florida Statutes*:

- Seat 1 La-el Carter Belmont II Community Development District
- Seat 2 Carl Brothers Belmont Community Development District
- Seat 3 Shannon Carey Belmont Community Development District
- Seat 4 Jennifer Holliday Belmont II Community Development District
- Seat 5 Kristen Brooks Belmont Community Development District

SECTION 6. CHARTER. The Merged District shall be governed by the provisions of Chapter 190, *Florida Statutes*, as amended. Consent is hereby given to the Merged District's Board of Supervisors to exercise of the powers set forth in Section 190.011 and Sections 190.012(1), (2)(a) - (d) and (f) of Chapter 190, *Florida Statutes*, as amended.

SECTION 7. EFFECTIVE DATE. This Ordinance shall be effective immediately upon receipt of acknowledgment that a copy of this Ordinance has been filed with the Secretary of State.
