Accept a Performance Letter of Credit in the amount of \$27,607.56, a Warranty Letter of Credit in the amount of \$217,871.08 and authorize the Chairman to execute the Subdivider's Agreement for Construction and Warranty of Required Improvements. Also accept a Performance Letter of Credit for Placement of Lot Corners in the amount of \$7,500.00 and authorize the Chairman to execute the Subdivider's Agreement for Performance - Placement of Lot Corners.
