No direct financial impact to the County will occur as a result of this petition. Of the approximate total of \$11,651,020 budgeted for COD-qualified common area infrastructure development costs ("common costs") within the expansion area, it is estimated that \$6,142,884 (or about 53%) of total development costs will be funded with long-term CDD bond proceeds.
